Greetings Minnesota Amateurs:

I'm sending this message to you as a request for you to get involved with a piece of legislation making its way through the US Senate.

S 1536 specifically is this:

"Avoiding Life-Endangering and Reckless Texting by Drivers Act of 2009 or the ALERT Drivers Act - Requires the Secretary of Transportation to withhold 25% of a state's apportionment of certain federal-aid highway program funds for the fiscal year if the state has not enacted or is not enforcing a law that: (1) prohibits, except in an emergency, an operator of a motor vehicle from writing, sending, or reading a text message using a hand-held mobile telephone (excluding a voice-activated device); and (2) requires, upon conviction of a violation of such prohibition, the imposition of certain minimum penalties."

What I am encouraging you to do is to write Senator Klobuchar and ask her to support an amendment, which exempts Amateur Radio from this bill. This is vital to our ability to operate mobile for everything from pleasure to emergency communications. Most of us have some ham gear in our vehicles, and we need to ensure that we can continue to use it when we desire. Currently the bill is in committee, and that is where the changes can be made.

The ARRL has a special section for Government Relations on its web site that can provide you with additional information on legislation that you encourage your Senators or Congressman to support.

MS 2010 TRAM Ride: A Letter of Thanks was received 8-21-10 by the BAARC. The group thanked us for the use of the repeater, which they considered "a valuable asset to the safe and efficient conduct of the ride." They were consistently praising the reliability and coverage of the repeaters on their path. Amateur radio is their primary means of safety communications and was a big factor in the zero-accident ride. They provided the following details to give us an insight as to the importance of the communications and logistics. Over 880 riders participated, 650 volunteers assisted, three trucks were used to move riders' luggage every day, and four vans with trailers were also used to pick up and transport riders with difficulties along the routes. Additionally, thousands of gallons of water and thousands of snacks were provided at many different rest stops. Again, they recognized that "coordinating all of this with the inevitable on-the-fly changes would have been impossible without the use of the WØUJ repeater and the others along the route. Our ability to manage our crises without the repeater shows its potential in a real crisis." At the end of the letter, they say they would like to have us join them for next year's ride. It was signed by **Will Ziegenhagen**.

DX and the Paper Chase

Out of the last 14 QSL requests I sent out, I received 13 confirmations...not too bad. I am a bit disappointed that the station I worked on Maldives (8Q) has not returned my request, but 13 out of 14 isn't too shabby. DXCC 300 is right over the horizon for me. Now to the important stuff: lets face it, the bands have been iffy the entire month of August. Does that mean there is no DX to chase? I think not. There's an old proverb that goes "when the going gets tough, the tough get going." I found out quite late one evening that snow falls in New Zealand after a ZL4 answered my CQ—and don't think that didn't get the old heart pumping. As usual I cruised the band with nothing heard but static before calling my CQ, landing in ZL-land with little effort at all. Up until today (August 23rd) sunspots are nonexistent, but that didn't stop me from joining in the fun of operating Europe with pretty darned good signals. A couple on nights ago, well after sundown, I answered a CQ on 17-meters from an Italian mobile station with superb signals both ways, and it was midnight in Western Europe. Propagation can be fickle, but I've learned one thing over the years: don't pay any attention to the Internet sites that give you the SFI and the indexes (A & K) because if you do, you'll be discouraged. I use the tried-and-true method of calling CQ, and that's something the sunspot gurus know little about. Up until an hour or so ago European stations were calling North America—and what fun that was! Working into JA-land around 8:00 PM Central time has brought some fun QSO's from Japanese stations, who I consider the best operators on the ham bands. Anyway,—what I'm saying is that there is always DX available somewhere in the world as long as you sit down at your station and call CQ because there's someone listening somewhere in the world for your signal, don't disappoint him or her! So long from Huntersville, 73 and good DX from Bob/WØZPE.

Happy Labor Day to all who have toiled and who are still working. We owe much to you who have made this country great, no matter the nature of the work—all adds to the quality of life we enjoy today and in the years to come. **Big Thanks to you—belatedly!** We hope you enjoyed the Holiday that recognizes the value of your labor past and present.

News: ARRL Amends *Petition to Deny* to Include 16 Additional Recon Scout Applications -- 08/18/2010

On August 16, ReconRobotics -- in response to the [ARRL's Petition to Deny Applications](#), filed with the FCC on August 4 -- filed an *Opposition to Petition to Deny* with the FCC, arguing that the ARRL's *Petition* is "frivolous." The ARRL's *Petition* asked the FCC to deny 68 pending Public Safety Pool license applications associated with the [ReconRobotics Video and Audio Surveillance System](#), specifically the Recon Scout device.

Calling the "frivolous" contention "somewhat amusing, given what the FCC had done three days earlier," ARRL Chief Executive Officer David Sumner, K1ZZ, pointed out that on August 13, the FCC returned the first application -- submitted by the City of Salina, Kansas. The Salina Police Department had asked the FCC for a waiver to operate the Recon Scout in the band 433-445 MHz. The FCC returned the waiver request to Salina, noting that the frequency band requested was not consistent with the waiver *Order* ([Docket 08-63/DA-291](#)) which requires that the first unit licensed to an eligible entity operate in the band 436-442 MHz. "We expect that the application will be corrected and resubmitted," Sumner said, "but it is encouraging to see that the FCC agrees with us that the applications -- this and all of the subsequent ones filed -- are defective in this respect."

The ARRL's *Petition* noted these and other incorrect technical parameters in each filed application, stemming from errors in the grant of equipment authorization for the ReconRobotics device, as well as inconsistencies between the applications and the FCC waiver grant for the device in Docket 08-63. Since the August 4 filing, the ARRL has noted another 16 applications have been filed with the FCC, requesting a waiver to be able to use the Recon Scout in the incorrect frequency band. On August 17 the ARRL amended its original *Petition to Deny Applications* to include these 16 additional applications.
